### PARCC UPDATES: BRYAN BILSE

#### A. NARCAN STATISTICS FOR 2021

- i. Final Statistics for Narcan Training and distribution
- ii. MPARCC in 2021
- iii. Four hundred and thirteen doses of Narcan were distributed in 2021
- iv. Nine Naloxon Boxes were distributed and installed in Columbia County businesses
- v. Bryan thanked the PARCC Members for their guidance and assistance in getting Narcan out to the citizens of Columbia County

### **B. NARCAN IN THE COLUMBIA COUNTY JAIL UPDATE**

- i. Smaller bags have been ordered so they are easier to store and handle by correction staff
- PARCC Members Bryan Bilse, Tom Drury and Jake Neisen met with Captain Jim Stilson and Lt. Brian Kjorlie for a 90 day review of the program
- iii. Lt. Kjorlie will place signage in the jail and release area letting people know that anyone in need of a Narcan rescue bag can receive one

- iv. There will be another review of the program in March of 2022
- v. A Total of approximately fifty five bags have been distributed to the jail since the start of the program

## C. UPCOMING NARCAN TRAININGS

- Thirteen members of the School District of Lodi kitchen staff were trained in the use of Narcan on January January 26<sup>th</sup>, 2022. Please let Bryan or Paula know if you know of any other schools or businesses which would like to receive Narcan training
- ii. Employees at the Market Basket in Portage will be trained and a box installed in their business in February 2022
- iii. Neil's Wine House in Portage called and requested a Naloxone Box. Neil will take the training held at the Market Basket

### D. DRUG TAKE BACK DAYS

Drug take back day is scheduled on April 30<sup>th</sup>, 2022 from 10 a.m. – 2 p.m.

### E. TOBACCO AND ALCOHOL COMPLIANCE CHECKS

- i. Bryan is in the process of planning tobacco and alcohol compliance checks with Law Enforcement in Columbia County
- ii. Tobacco checks will start in March of 2022
- iii. Alcohol checks will start in April of 2022
- iv. PARCC is still looking for people age 19 or 20 to assist with the alcohol checks

# F. HANDLE WITH CARE PROGRAM (PAULA)

- i. Paula gave an update on the Handle with Care Program
- ii. Five Schools along with their respective police departments have signed an MOU and will participate in this program
- iii. Paula showed a copy of the drop down screen the police officers will use while filling out their collected information
- iv. Paula talked about how each school can decide what to do with the information they receive

v. Participating agencies will be contacted in the future to see if the program is being used and if any changes need to be made

## G. NOVEMBER GROUP ACTIVITY AND UPCOMING SURVEY (PAULA)

i. Paula provided copies of the results of the group activity for the group to reflect on. There was a brief discussion about moving the PARCC Meetings to other locations outside of Portage. It was decided to leave the meetings in Portage and reevaluate in the future

ii. Paula informed members of an upcoming survey which will be sent to them with the February Meeting Agenda. This survey is part of the grant requirement through the state

iii. PARCC will be having an awards celebration in April or May of 2022. Award nominations forms will be sent out to members in February

iv. Paula provided a list of goals for PARCC for 2022. Each member was asked to vote for their top three goals by placing a sticker next to it

# H. UPDATES FROM THE GROUP

### **UPDATE FROM TOM DRURY (PARCC)**

- Tom announced the new PARCC Executive Team for 2022. The Executive Team consists of: Ellen Ellingsworth (HHS), Monica Neumann (TBH), Brian Johnson (COSO) Faith Gladen (Harbor Recovery Center) and Adria Schroeder (Lodi Schools)
- ii. Tom gave an update on the Opioid Lawsuit Listing Sessions which he took part in. Thirty percent of the money received will go to the State of Wisconsin and seventy percent will go to counties. Litigation is still going on in this lawsuit

### **UPDATE FROM JAMIE ZIEGLER (DRUG COURT)**

i. Jamie reports many of her clients are doing a great job and are moving out of the first phase of the program. Jamie said there is currently room in the first phase of her program

### **UPDATE FROM KRISTIN SCHMITT (OWI COURT)**

- i. Kristin had one person graduate from OWI Court this month and two will graduate next month
- ii. Kristin received three new referrals last week and continues to be very busy

### UPDATE FROM MARISSA FREDRICKSON (DOC- PROBATION AND PAROLE)

i. Marissa stated the state is creating an Opioid Advisory Team which will help provide better treatment options for people leaving prison. This team will work with MAT Providers.

### FAITH GLADEN (HARBOR RECOVERY)

- i. Faith announced the Harbor Board has been meeting weekly
- ii. Harbor will be house at Cooper Hall in Portage
- Harbor will take residence in Cooper Hall on March 1<sup>st</sup>, 2022 with the middle of April being the target date to be open to the public for services
- iv. A website is being created at this time

### JAKE NIESEN (SATORI HOUSE)

- Jake reported success with the Juneau County Jail with peer support and Narcan distribution. Peer support within the Sauk County Jail is on track to start soon
- ii. Jake told the group Aspirus Hospital in Portage has been a very good partner with Satori House by providing several referrals for services

## **REBECCA KAISER (TRANSITIONS BEHAVORIAL HEALTH)**

 Rebecca announced that she and Jessica Beckett have passed a National exam for the position of Clinical Substance Abuse Counselor. This will allow Rebecca and Jessica to provide more intensive group treatment

## JESSICA BECKETT (TRANSISTIONS BEHAVORIAL HEALTH & OFR)

- i. Jessica gave a report about the OFR Group
- ii. There were 22 overdose deaths in Columbia County in 2021 compared to 8 overdose deaths in 2020
- iii. Jenna from Public Health will be assisting Jessica in creating an OFR report. Jessica encouraged members to provide feedback about what statistics should be included in the report

# Monica Neumann (TRANSISTIONS BEHAVORIAL HEALTH & MAT PROGRAM)

- i. Monica indicated Angela Smith (HHS) will be on leave until April. Stephanie Nickel (HHS) will be covering while Angela is on leave
- ii. Due to the high number of consumers and referrals, the MAT Program will need to hire a second coordinator in the near future
- Monica provided the group with some MAT statistics: Thirty clients open status, two new referrals this week, fourteen open intake and sixteen open to case management
- iv. Monica advised the group that Cassie from (NNAI PROGRAM) mailed thirty two letters to inmates who have been released and didn't receive any treatment options while they were incarcerated

# CHERYL ANDERSON & PAT DRURY (SATORI HOUSE)

- i. Cheryl introduced herself to the group
- ii. Pat indicated that Satori House and the MAT Program have been working together to provide consumers faster treatment options
