- ii. Contact had been made by Columbia County Lt. Brian Kjorlie about a narcan save in the jail recently. The narcan used had been provided by PARCC
- iii. PARCC will provide narcan training to the Arlington Fire Department and the Poynette EMS Service this spring. An update will be provided after the training takes place
- iv. Bryan provided an update about the tobacco grant. Bryan and Monica from Transitions Behavioral Health met in person with State Representative Alex Dallman
- v. Bryan provided an overview for the INDEPTH and Prime For Life Programs in which he currently teaches at the Lodi Middle and High Schools. Expanding these two programs county wide would be

Doug said the Columbia County Board voted to support Alcohol Treatment Court through the tax levy. The plan is to fund Drug Treatment Court next year with money from the opioid settlement money
