PARRC UPDATES: BRYAN BILSE

A. Narcan Training and update on Naloxone Boxes

- i. Bryan partnered with the Portage Police and the Columbia County Sheriff's Office to provide training to the Columbia County Tavern League
- ii. Bryan trained 60 people who represented 16 taverns in Columbia County in the use of Narcan
- iii. A representative from each tavern was provided one box containing two doses of Narcan
- iv. Bryan showed the group what a Naloxone Box looks like and explained how to obtain one for their tavern
- v. Four Taverns including: Johnny B's, Lucky Aces and the Cottonwood Bar have expressed interest in installing a Naloxone Box
- vi. The Harmony Bar in Poynette was provided a box this week
- vii. Bryan will notify law enforcement concerning which taverns in their jurisdiction have Narcan or a naloxone box
- viii. Paula Enger said the Portage Cab Company was contacted about Narcan training and having staff carry Narcan while working. Portage Cab Company is not interested at this time but hopefully in the future

B. NARCAN TOTALS FOR 2021

- i. Bryan provided the following information concerning Narcan training and distribution in Columbia County so far for 2021
- ii. One hundred and seven people have been trained in the use of Narcan
- iii. One hundred and fifty four does of Narcan have been given out
- iv. Seven Naloxone boxes have been provided to area business

C. OVERDOSE STATISTICS NATIONALLY

- i. Bryan provided National overdose statistics from the Centers for Disease Control and Prevention. This information was in the local and national press
- ii. It was reported approximately 100,300 people have died of drug overdoses from May 2020 to April 2021

D. MEETING WITH REPRESENTATIVE CONSIDINE

- i. Bryan reported as part of the tobacco grant it is required to meet with state representatives
- ii. Bryan along with Coalition members Tom Drury, Jamie Ziegler and Angela Smith spoke during the virtual meeting with Representative Considine
- iii. Bryan provided information concerning the tobacco control movement and funding for this program
- iv. Jamie provided information and statistics on Columbia County Treatment Court
- v. Angela provided information and statistics on the Columbia County MAT Program and Crisis Intervention

E. DRUG ENDANGERED CHILDREN (DEC) GROUP UPDATE

- i. Paula gave an update on the Handle with Care Program which the DEC Group is working to restore
- ii. All Law Enforcement agencies have signed the MOU

- iii. Schools are being currently contacted to determine contact information
- iv. Paula said a target start date for the program is December 1st
- v. Andrea is currently working on a fillable form for Law Enforcement to use on their squad computer
- vi. Handle with Care Form will be filled out by law enforcement if they are aware of a child being exposed to a traumatic event. Law enforcement will send the form to the proper school for review
- vii. Next DEC Meeting will be held Thursday, January 27th at 12p.m. before the PARCC Meeting. This meeting is closed but let Paula know if you are interested in being part of the DEC Committee

F. NOMINATION OF COALITION CHAIRPERSON

Nominations were opened up to the coalition. Dan Garrigan nominated Tom Drury. No other motions were brought forward. Dan Garrigan made a motion that we accept Tom Drury as the coalition chairperson for the next two years. Jamie Ziegler seconded. No discussion. Motion carried unanimously. Tom Drury accepted the position.

- i. Coalition members had a discussion about how to grow our coalition
- ii. Ideas were shared in small groups and will be discussed at the January meeting with the whole coalition

- i. The Portage Police will be working with Sotori House to provide peer support for people when police have contact with them and support is needed

- iii. OWI arrests in 2021- 341

Update from Stephanie Nickel Columbia County HHS

- i. Background checks are being conducted for people to provide peer support

Update from Monica Neumann MAT

- i. There have been eight new referrals for the month of October
- ii. There are currently 18 open referrals
- iii. MAT is working with the Portage Police Department to receive self-referral's for the program

Update from Rebecca Kaiser & Jessica Beckett (OFR) (MAT)

- i. Monica Neumann is taking over the AODA Group which meets at Transitions
- ii. Methamphetamine seems to be the biggest issue right now
