A. Update from Faith Gladem Harbor Recovery Center

- i. Faith reports there have been 85 referrals since the recovery center opened in April of 2022
- ii. Next Rise Up For Recovery Event is Saturday, December 3rd from 1-4p.m. at Harbor
- iii. Faith indicated the church property has been purchased by a new church and Harbor has been asked to move from Couper Hall. Faith would like to remain in the downtown area of Portage.
- iv. Faith asked members to keep their eyes open for available property

B. Update From Doug Richmond Columbia County Board Member

- i. Doug reported OWI and Drug Court, along with the Public Health Position was put back into the county budget for next year
- ii. Doug talked about the Opioid Settlement money which is being given to Columbia County
- iii. Doug said a committee has been formed to determine where the opioid money should go. A presentation will be given to the Columbia County Board at a later date to discuss the distribution on the money

C. County Wide YRBS DATA Presentation Bryan Bilse

- i. Bryan gave a presentation on YRBS DATA from six schools in Columbia County
- ii. Students took the YRBS Survey in 2021
- iii. Students will take the Survey again during the spring of 2023

D. PARCC Theater AD

- i. The final copy of the PARCC Theater AD was shown to the group
- ii. The AD started showing in the Portage movie Theater on November 15th and will continue til February 15th, 2023

- i. Marissa reports Narcan is given to people who are leaving jail or prison who are at a high risk of opioid misuse

F. Jamie Ziegler (OWI and Drug Court)

- i. Jamie reported she is running both courts right now. She is very excited to be staying in her current role.

G. Adam Rogge (Police Chief Poynette Police)

- i. Adam expressed gratitude to PARCC for providing NARCAN to their department

H. Jenna Retzlaff (Columbia County HHS)

- i. Jenna reported nine ER overdoses recently
- ii. 33 % of these overdoses were people 19 or younger

I. Rebekka Cary- (CVSO)

- i. Rebekka let the coalition know the VA is trying to prescribe less opioids to veteran patients. A whole health and wellness team is assigned to the veteran patient when a they are prescribed opioids

J. Kari Due (Aspirus)

- i. Kari said she is reaching out to her connection at ED-2 recovery and is looking for any ideas about peer support for Columbia County

K. Jessica Beckett- (TBH)

- i. Jessica reports that Monica has finished CCS Training

L. Monica Neumann- (TBH)

- i. Monica reports she has finished CCS Training
- ii. Monica said The CCS Program opens doors to many community programs for the clients

M. Sara Shaver- (Compass)

- i. Sara said the Grieve support group is going very well. It meets at Compass the 2nd Wednesday of each month
- ii. Sara reported a new staff member is starting next week
