- 4. Prevention Update:
 - a. State Prevention Conference takeaways
 - i. Dr. Michael McNett, Medical Director of the Aurora Health Pain Clinic: We've led patients to believe that we can make them totally pain free, making them overly reliant on pain meds, when in fact it's more reasonable to expect we can function normally with low levels of pain. Also, research shows the effects of narcotic pain receivers diminish fairly quickly, so prescriptions show before short periods of time, i.e. smaller quantities.
 - ii. Various speakers on coalition building: Confirmed that PARCC is a successful model for bringing a variety of stakeholders (criminal justice systems, health care providers, family members, treatment providers, etc.) to address the heroin/opioid crisis.
 - iii. It was great to come together with so many people from across the state who are working on the same goals as PARCC. I attended many of the sessions on alcohol and it really opened my eyes to what we can be doing to educate and work with leaders in each community to improve the environment at the local level.
