4. Prevention Update
 - a. National Night Out
 - i. Lodi & Columbus boosted on PARCC Facebook page
 - ii. PARCC booth at both locations
 1. Currently have 75 lock boxes & the bags are on backorder
 2. Boxes will contain MATRS card, Detera disposable bag, & med drop off magnet
 - b. Lock Up Your Meds Campaign – posters & 500 magnets available
 - c. PFS Grant Cycle - \$50,000
 - i. Renewal was due last month
 - ii. In place of Life Skills curriculum have added assisting police in drug addiction (MOU needed)
 - iii. Paula to e-mail list of strategies to PARCC members
5. Update from Rep. Considine – latest legislation.
 - a. 11 additional bills recently signed into law; a number signed off from previous legislation; money should be allocated in this 2 year cycle (not contingent on state budget)
 - b. New pieces:
 - i. Getting screening assessments for drug assessments in schools
 - ii. Funding for 4 more criminal investigation agents in state to focus on drug trafficking
 - iii. Creating a recovery charter school (up to 16 students at a time) likely to be located in Madison or Milwaukee areas
 - iv. Funding for Wisconsin doctors residency

- v. Create an addiction consultation program so primary providers can call in to addiction specialists
- c. Attended Attorney General's Listening Sessions
 - i. Looking into legislation regarding changing Medicaid termination after prison
 - ii. Believes state should fund some regional hospitals to do mental health things instead of sending patients to Winnebago
- d. Meth – keep on radar
- e. Currently against legalization of marijuana but has heard some things regarding reduced opioid rates in Colorado; please send input to his office with your thoughts

6. Response Update

- a. MATRS program continues to go well with Sauk County – currently full (50+)
- b. Just submitted budget for year 3: funds split equally between Columbia and Sauk
 - i. Largest need in Columbia was adding additional CRS; currently looking to hire!
 - ii. Partnering with Tellurian to get credentialed in CCS
 - iii. Cross training with Columbia County's Crisis Department
- c. Stocking up on Vivitrol; ordering a fridge
- d. Portage office (in old St. Vincent's building) is almost open; had to re-order new desks to get set-up
- e. Tellurian's recovery group meets Wednesdays in Baraboo; accepts various insurances
- f. In response to stakeholder meetings, hosting non-denominational clergy group 07/31 at Columbia County Health & Human Services to be trained and on-call to connect with someone who overdoses
- g. August will be official year of funding of MATRS grant and successful clients will be invited to the PARCC meeting for a celebration

- b. National Opioid Discussion with Rep. John Nygren today – attended by Kory Morgan, Chief Dan Meister, Lt. Roger Brandner, etc.
- c. Free Naloxone trainings available in region; Amanda Riek will connect with Paula on opportunity
- d. Amanda will be attending National Prevention Network Conference in California in September
- e. Public Defender's Office working on presentations to do in schools to "Know Your Rights"
