## 7. Response/Treatment Committee Notes

- a. Three main strategies to focus on:
  - Inpatient/sober living options detox through 6 mos, for safety, support & stability
  - ii. Counseling dually credentialed, mental health, AODA and family support
    - Immediate, consistent, educated on MAT/ACES/Trauma, wrap around model
  - iii. Prescribers specialized in MAT & MH medications (anxiety, depression, sleep, etc)
    - PCPs/APNPs/PAs bearing the load need psychiatrists to step up, expand MH APNP/PA options
