 - a. MARC fully staffed, funded, collaborating with CCS, Drug courts-Sara Berger in house crisis AODA social worker, MTT, LSS contracted overflow; NNAI mat/jail grant-\$114,000; requesting full time social worker, hhs/jail/mat intakes; OD mapping grant-collaborate with Law enforcement, hhs, public health, etc., PT case manager; In home crisis diversion, stabilization youth grant (Green, Sauk, Waushara)-LSS response team of 2, after hours availability; Legislative brunch 12/7/18 8-10 am; Pharmacy pilot with UW school of pharmacy and medicine, HHS & Wilz Hometown; Madison Trauma Therapy now in Portage & taking referrals from DHHS
3. Report out from those who attended Opioid & Meth Conference
 - a. Kory - "Way Out" program where an individual could report, turn self in, no questions asked for treatment; based on Wood County UA program suggestions; has Atty. General support; gentleman from IL willing to come talk to PARCC about the program!
 - b. Meghan - Meth Lab set up; enjoyed family presentation re: impact; response & follow up programs post OD, HHS, LE, etc with family go to house, call etc; Notes Attached

4. Mental Health Work in Lodi Presentation - Tiffany Loken
 - a. Social Emotional Learning (SEL) team has been established; researching different programs to pilot in Lodi beginning next school year; hoping dollars for these programs continue to be funded moving forward
5. Committee Updates
 - a. Community Outreach - **Legislative Breakfast event partnering with TFCDC:** Dec. 7th @ CC HHS 8 - 10 am, need to RSVP...32 confirmed, with room for about 50; **Columbia County Youth Retreat:** Feb. 12th @ Wintergreen in WD,

open to students in 7th - 11th grade, all school districts in Col. Co. (max 10 students per school), breakout sessions (Trauma & Resiliency, Celebrating Diversity & Inclusion, Healthy Relationships, Mindfulness/Coping Skills)...flyer attached for reference

- b. First Responders - Working on identifying the contact person for each school district to get forms to the schools (re: Handle with Care)...Meghan is working on this; Roger updated that Fall River is only school district still needed
 - c. Wrap Around Services - Jake attended meeting @ RAM/historic & thought it seemed fine for NA/AA meeting location, but no official opinion yet...still looking into other sites for meeting; Jake & Amanda will be meeting with Shannon Wojciechowski to discuss options for wrap around services; Jake still looking for House Manager & has pushed back opening Satori House (resident application attached) until position filled (looking for single male, at least 9 months sobriety); Agents are low, challenges with coordination, ATRs, etc; ALJs not embracing opioid needs vs. public safety; Jail/Probation & Parole/Law Enforcement referrals to MARC continue to be critical

- a. Ken - Of 13 alcohol compliance checks done earlier this month, Portage had 3 fails; Portage also had 7 heroin ODs in past month, all revived with Narcan; Shared article on how to deal with addiction during the holidays (handout attached)
 - b. Michael - State Patrol in need of more DRE officers to be trained, as officers are being too spread out; In Col. Co. out of 200 arrests, 50+ were drugged driving
 - c. Dennis (DHS) - Shared "Save the Date" info for upcoming conferences in Green Bay (Save the Date flyer attached); Both conferences will be held @ KI Center in GB: Mar. 19th - 20th "Opioid Forum" w/ Mar. 18th, waiver training for prescribers...April 2nd - 3rd "Wisconsin's Opioid Crisis: A Trauma-Informed Response" w/ April 1st pre-conference re: tribal communities
