- 1. Minutes from last meeting approved
- 2. PARCC Goals Review
 - Moving forward, please keep any PARCC related updates to 3-4 minutes; if you
 have something to share that will take longer, please send to Paula and it will be
 added as an agenda item
 - b. Paula provided an overview of where PARCC started; taking a look back to where group started to help us look at where we're going moving forward; this will be addressed further at next month's meeting, but please think about what you think are some of the most important issues PARCC should be addressing; working with Stacy, smaller action teams have been put together but a lot of this hasn't gotten going yet; proposal put forward for meeting structure moving forward: 1 hour for agenda items & updates, and 1 hour dedicated to work time for action teams
 - c. Tom added that now that PARCC is an established group, we should definitely look at where to go from here; Dawn suggested under the "solutions" (posted on wall during meeting) to add what's been done through outside agencies, not just PARCC...group agreed with this.

3. Prevention Updates

- a. STR Grant this is money from the state for things (lockboxes, Narcan, etc.);
 under this grant through PARCC, we can only apply for money for Narcan trainings
 - Larry added there is a statewide order that allows pharmacies to dispense Narcan to anyone that requests, if the program is in place at the individual pharmacy; also noted that Hometown has a Narcan training program in place

- b. PFS (Partnership for Success) Grant this grant is very specific on what dollars can be spent on; \$50,000 grant per year, which mostly covers coalition staff; dollars also used for increasing coalition's speaker's bureau, theater ad, Hidden In Plain Sight display items, and usually DRE trainings...currently don't need more DRE officers, but will be getting supplies for officers
 - i. Emily added that if PARCC would like to have the Hidden In Plain Sight display as a "virtual tour" on the website, she has a contact who can make this happen for us
- c. County Youth Retreat this is a prevention action team that has just started working, in partnership with the CARES group; first step is putting together an informational meeting for administrative support staff from each of Col. Co's 10 school districts in October, to get their buy-in and input on what topics they'd like to see their youth learn about; second step will be planning the youth retreat, which will be held sometime in the early Spring (February/March); action team agreed that the goal for the youth retreat should be educational, with a focus on changing school climates, and then giving students tools to take back with them to their respective school districts

4. Response Update

- a. Moving forward with MATRS Clint provided the following information on where they stand: have not been able to get approved on hiring staff or finding an organization to take over the program; looking at a hybrid version for MATRS program moving forward (rewrite jobs/reclassify); at this point people are covered (program participants), but on a temporary basis at this time
- b. Dawn passed out flyer for faith-based opioid summits coming up in October (attached); SOR (State Opioid Response) grants will be replacing STR funding & will be increasing, with more money going into prevention/Naloxone

5. Susan Lorenz - Grant possible through Public Health

- a. OHPP \$20,000 grant to Col. Co. to develop communication strategy using the CDC's Rx Awareness campaign; through Col. Co. HHS, funding would be used to develop individualized communication plan using this campaign; someone needed full-time to work on this; materials are already made, just need to figure out how to roll it out
 - i. Emily mentioned that through Columbus hospital, they have people who can create the marketing campaign for this
 - ii. Emily also gave a brief overview of the 4-part video series that is already being developed through the hospital; "shock and awe" campaign to debunk common myths of the opioid crisis (myths that it's not in rural communities & that it's just a certain type of person who gets addicted)

6. Det. Lt. Roger Brandner

- a. Opioid Mapping contact for this is Deputy Dave Clark, to be notified of overdoses in Col. Co.; he needs to know the date, location, and drug
- b. Handle with Care program that partners the school districts with local law enforcement; if there has been a call to a child's home, law enforcement will

notify a designated school personnel to give them a heads up to keep an eye on that child during school the next day; no information will be given about the reason for the call, but it's a way to provide support to kids who may be having a tough day; so far response from schools has been lukewarm, but Roger (or another representative) will be at the school support staff meeting (see County Youth Retreat info above) to provide a detailed overview of the program

7. <u>Jacob Niessen Update</u>

a. Has recently bought a house for sober-living in Portage (Satori House): starting with men, but is for anyone in recovery, will not be discriminating on addictions; there will be a requirement for individuals to go to meetings; currently trying to find a house manager, but hoping to open within the next 2 months; looking to do a Spring fundraiser to cover costs

8. <u>Brochure Discussion</u>

a. Purpose of having brochure would be to get PARCC name & information out there more; proposed that we could create inserts to go into brochure with more specific substance related information, based on audience to be receiving materials

9. General Group Updates

- a. Tom grief support group in Poynette beginning on September 4th, for parents of person struggling with addiction
- b. Flora administration pushing "junk" insurance plans; FARM Bill is moving forward, has passed through the Senate; shared handout on Opioid Response Act, which if passed would allow data-sharing across state borders (attached)
