Marissa Fredrickson (P&P)- Let the group know that P & P are handing out Hope Kits to their clients. These kits contain testing strips, Narcan and other resources.

Joshua Paul (Harbor Recovery Center)- Harbor Recovery Center is also doing peer support within the Columbia County Jail. Joshua will be working with area businesses to provide resource hub information
